Minutes from the 2016 Annual Conference

1. Betsy Wilber shared updates from the Research Interest Groups Chairpersons meeting, including:
 - a. Consideration is being given for central submission for award nominations/applications.
 - b. Strategies used by other research interest groups to promote communication within interest groups, including member highlights, periodical newsletters, linked in.
 - c. Continued need for grant reviewers; rotating schedule in place for RIGs to provide representation.
2. Progress on Decision Making RIG 2015-2016 goals:
 - a. Guaranteed symposium was held with good attendance and good dialogue after presentations by those in attendance.
 - b. Applications were received and reviewed for our 2016 Emerging Scholar Award, with a nominee selected for the award. No applications were received for our 2015 Outstanding Dissertation/DNP award, so interest in the award process was increased this year.
 - c. Little progress was achieved in increasing networking among RIG members. A call for personal profiles yielded only a few responses. However, calls for abstract reviewers and reviewers for award applications did yield a response that facilitated accomplishing that work.
3. Dr. Lisa Carter-Harris was awarded our Emerging Scholar Award for her research on client decision making related to participation in lung cancer screening. Dr. Carter-Harris presented a very enlightening summary of her research to date, which clearly demonstrated her potential in decision making scholarship.
4. Dr. Lisa Carter-Harris accepted the position of chair elect for the Decision Making Research Interest Group. Her willingness to lead the group is sincerely appreciated.
5. General discussion included a suggestion to the MNRS planning committee that presentations to be given in RIG meetings by award recipients be included with the schedule of RIG meetings in the conference agenda so all MNRS conference attendees are aware of the planned presentations. This might increase attendance at RIG meetings and provide a wider audience for dissemination of award winning research and scholarship.
