PURPOSE OF THE AWARD

The purpose of this award is to recognize those who have made a substantial contribution to palliative and end-of-life care research or practice, who are more than 20 years post-doctoral degree, and whose work has consistently demonstrated advancing or translating the science of palliative and end-of-life care over time.

CRITERIA FOR THE AWARD

- The nominee should be considered to be an expert in the field, as demonstrated by distinguished and continuous contribution to the advancement and translation of palliative and end-of-life care science and/or practice throughout their career.
- The nominee's publication record reflects a continuous contribution to science and/or practice of palliative and end of life care throughout their career.
- The nominee has disseminated findings at local, regional, and national levels.

ELIGIBILITY REQUIREMENTS

- The nominee must be a regular member of MNRS in good standing.
- The nominee must be a current member of the MNRS Palliative and End of Life Care Research Interest and Implementation Group.
- Twenty or more years since receiving doctoral degree

SUBMISSION REQUIREMENTS *Each nomination packet should include:*

1. A statement from a peer colleague (1 page, single-spaced) that addresses how the nominee's work has made a distinguished and consistent contribution to the science and/or practice of palliative and end of life care
2. Two publications within the past ten years (if "in press", include letter of acceptance) that represent the nominee's program of work
3. Current curriculum vitae
4. Please be sure the submission materials are clearly identified with the nominee's name in the file name.
5. The nominee must acknowledge their willingness to be considered for the award.
6. Individuals may self-nominate. Self-nominations should include item #1 above, the statement from a peer colleague that addresses their work.

Applicants will be notified of the RIIG Awards Committee decisions in January of 2022. RIIG awards will be presented at the RIIG meeting during the Annual Research Conference. Each awardee is strongly encouraged to be present to receive the award.

CRITERIA FOR THE AWARD

- Has advanced the science and/or practice of palliative and end-of-life care.
- Has a publication record that reflects a continuous contribution to the science and/or practice of palliative and end-of-life care throughout their career
- Has disseminated findings at local, regional, and national levels.

ELIGIBILITY REQUIREMENTS

- The applicant/nominee is a member of MNRS and member of the Palliative and End-of-Life Care Research Interest Group.
- More than 10 years since receiving doctoral degree

SUBMISSION REQUIREMENTS

Each nomination packet should include:

1. A statement from a mentor or peer colleague (1 page, single-spaced) that addresses the significance of the nominee's contributions to the advancement of palliative and end of life science and/or practice
2. Current curriculum vitae
3. Two publications (if "in press", include letter of acceptance) that represent the nominee's work
4. Please be sure that all submitted materials are clearly identified with the nominee's name in the file name.
5. The nominee must acknowledge their willingness to be considered for the award on the nomination form
6. Individuals may self-nominate. Self-nominations should include item #1 above, the statement from a peer colleague that addresses their work.
7. If selected for the award, the nominee must be a member of MNRS and a member of the Palliative and End of Life Care Research Interest and Implementation Group

PURPOSE OF THE AWARD

The purpose of the Outstanding Publication Award is to bestow recognition on a Palliative and End-of-Life Care author for an outstanding published manuscript.

CRITERIA FOR THE AWARD

- Publication significantly advances the science and/or practice of palliative and end-of-life care.
- Publication is current (published within the past 1-2 years).
- Publication is in a peer-reviewed respected research journal.
- The applicant must be the 'first author' / or mentor on the publication.
- A publication may be submitted only once in a two-year cycle.
- The manuscript must have been accepted for publication at the time of submission for this award.
- Only one manuscript may be submitted per applicant.

ELIGIBILITY REQUIREMENTS

- The applicant/nominee is a member of MNRS and member of the Palliative and End-of-Life care Research Interest and Implementation Group.

SUBMISSION REQUIREMENTS

To submit for this award, you must include the following two items:

- A letter submitted by the author or a peer colleague who is familiar with the work that briefly outlines the significance, innovation, scientific rigor, and impact of the work to palliative and end-of-life care. Please include the following information in the letter:
 - ✓ Nominee name, credentials and contact information (self-nominations are welcome).
 - ✓ Reference for the publication.
 - ✓ Nominator's name, signature, and contact information (if applicable).
- PDF of the nominated manuscript

Applicants will be notified of the RIIG Awards Committee decisions in January of 2022. RIIG awards will be presented at the RIIG meeting during the Annual Research Conference. Each awardee is strongly encouraged to be present to receive the award.

- The nominee must have recently completed (defended) the doctoral dissertation within 1 year of the nomination deadline date

SUBMISSION REQUIREMENTS

Each nomination packet should include:

1. Letter of support (1 page, single-spaced) from a dissertation advisor/committee member that addresses the significance of the dissertation to advancing the science in palliative and end-of-life care, as well as the meritorious level of scholarship demonstrated by the applicant
2. Dissertation abstract
3. Current curriculum vitae
4. Individuals may self-nominate. Self-nominations should include item #1 above, the statement from a peer colleague that addresses their work.

1. Letter of support (1 page, single-spaced) from a DNP advisor or committee member that addresses the significance of the DNP project to advancing the science in palliative and end-of-life care, as well as the meritorious level of scholarship demonstrated by the applicant

4. Individuals may self-nominate. Self-nominations should include item #1 above, the statement from a peer colleague that addresses their work.
